
This letter is being written to bring your immediate attention to the prolonged closure of RT611 in Delaware Water Gap, Pennsylvania.

RT611 is owned and maintained by the Pennsylvania Department of Transportation (PennDOT) and runs through the Delaware Water Gap National Recreation Area in Monroe and Northampton Counties. RT611 is a critical public roadway for residents, commuter and business traffic, and it serves as an emergency alterative for a major interstate, RT80. On December 6, 2022, RT611 was closed due to a rockslide. PennDOT and I worked immediately to secure emergency funding and expedite specialized crews to ensure prompt attention to this roadway.

Understanding the importance of this road, PennDOT has been ready to begin the required work for a year - since January of 2023. <u>The State of Pennsylvania has made the reopening of this</u> roadway a top priority and we insist this be a priority of the National Park Service as well.

National Park Service officials have yet to issue PennDOT a Special Use Permit, which is necessary to begin the required work. As a state Senator, I acknowledge the need to comply with statutes and regulations. However, I also fully understand the internal importance of prioritization within the bureaucratic process.

This prolonged closure has led to more severe consequences than necessary. Local businesses have suffered, residents are facing increased commute times with limited access to essential services, and public safety concerns continue to heighten. Enclosed are statements from local business owners, residents, and local officials sharing the impact this closure has had on them personally. I encourage you to read each one.
